






## Do you currently accept credit card payments from your customers?

- Below points will assist you in your discussion with your bank/preferred merchant acquiring provider:
  - Visy credit card transactions are "card not present" transactions, meaning there is no physical card that you will be swiping.
  - As you will not need to swipe a physical card, a web portal may be a more suitable, cheaper option for you rather than a physical credit card machine.
  - As payments from Visy will be via a single-use credit card, issued for an exact amount, you will need to ensure your transaction limit is high enough to process the value in one transaction.

# **Receiving a Credit Card Payment**



### Credit Card Numbers and remittance data are automatically sent to you via secure email.

An e-mail with the Credit Card payment details needed to process payment is sent securely to the e-mail address that your organisation provides to Visy. You will receive a separate e-mail for each Credit Card payment.


 Email will include details for the transaction. These details will allow processing of payment as per a normal card transaction today.

### **Details Included:**


- 16-digit credit card number
- Validity date,
- Unique CVC2 (e.g. 3-digit security code typically located on the back of a physical card)
- Corporate billing address of Visy.

### **Preparedness for Credit Card Acceptance:**

- Accept credit card payments today.
- Confirm email address with Visy ideally, group email rather than individual email addresses e.g. accrec@abc.com.au.
- Agree timings for first email to be received to ensure no issues regarding receipt.
